1. Approval of Agreement for Personal Services for Grant Administration, Implementation and Acquisitions with Donald R. Ward & Associates, Inc.

Mr. Langley informed the Council that both the State Division of Emergency Management and Don Ward have approved the contract for personal services.

Vice Mayor Erickson made a motion to approve the agreement for personal services for grant administration, implementation and acquisition between the City of DeBary and Donald R. Ward & Associates, Inc. Council Member Conoley seconded. The motion passed unanimously.

Mr. Langley explained the federally funded subgrant agreement with the State to the Council.

Vice Mayor Erickson made a motion to approve to approve the federally funded subgrant agreement with the State of Florida Division of Emergency Management. Council Member Marks seconded, and the motion passed unanimously.

## **XII. Council Member/Committee/Staff Reports**

1. Member Reports/Communications
  - A Mayor and Council Members

Council Member Lenzen informed the other members that at a recent Volusia County MPO meeting, they were discussing the submittal of projects. He asked the Council if they wished to submit a letter regarding the raising of US Highway 17-92.

The Council discussed Council Member Lenzen's request and agreed there is a need to raise the road.

Vice Mayor Erickson made a motion for the city manager to draft a letter to FDOT in reference to raising US Highway 17-92 in front of the entrance to DeBary Golf and Country Club. Council Member Marks seconded. The motion passed unanimously.

Council Member Marks reminded everyone that a stormwater workshop should be scheduled.

Mayor Garcia said he met with Deltona and Orange City regarding the possibility of regional fire services. He noted that the DeBary fire station is in very poor condition, and they are currently working on a list of deficiencies in the building. He informed the other members that DeBary submitted a request for \$12.2 million for the stimulus packet.

Mayor Garcia updated the Council regarding the Volusia Council of Government's (VCOG) resolution for the Volusia Growth Management Commission (VGMC). He stated that VCOG

forwarded it to Volusia County for direction, and then it would be given to the cities for consideration.

Council Member Conoley read aloud two letters he sent to the St. Johns River Water Management District.

B. City Attorney

Mr. Ardaman and Mr. Langley had nothing to report.

C. City Manager

Ms. Courson spoke briefly about watering restrictions and stated that the City does not have enforcement authority on violations because there is not a water conservation ordinance on the books.

Mr. Ardaman requested advice from the Council concerning the two pending lawsuits and advised the Council that the plaintiff has failed to pay the City approximately \$27,000 in fees. He clarified that the fee is not part of the litigation, and if the Council chooses, it would be appropriate to discuss the matter prior to the executive session.

Mayor Garcia read aloud the persons attending the executive session, noted that the executive session would last approximately forty-five minutes, and closed the public meeting.
