MINUTES

I. Call to Order

Chairman Harvey called the meeting to order at 9:00 a.m.

II. Roll Call

Members Present: John Harvey, Mary Hall, Marion Lane, Gene Leighton and Josephine Opisso

Others Present: Volunteer Coordinator Alan Williamson and Captain Alan Osowski

III. Approval of Minutes

1. Regular Meeting held November 9, 2005

Chairman Harvey noted that Mr. Leighton arrived to the meeting late and was not absent. Ms. Lane made a motion to approve the minutes as amended. Mr. Leighton seconded. The motion carried unanimously.

IV. Old Business

1. Review of Presentation to City Council on December 7, 2005.

Chairman Harvey gave the Committee a brief overview of his presentation to the City Council on December 7th. He said that the Committee's proposal to Council for the safety measures to be installed on the City trucks was well received. He noted that a Council Member suggested the addition of a defibrillator to each City vehicle, as well. Captain Osowski recommended that the Parks & Recreation personnel should be trained by the Fire Department prior to using a defibrillator. Chairman Harvey added that personnel should

also be trained in basic first aid and the use of a fire extinguisher. Mr. Williamson stated that both the City Manager and Assistant City Manager are aware of the recommendations, and are currently discussing them.

V. New Business

1. Election of Officers for 2006

Chairman Harvey asked for nominations for Chairman. Mr. Leighton nominated John Harvey. Ms. Lane seconded. The motion carried unanimously. Chairman Harvey asked for nominations for Vice-Chair. Mr. Leighton nominated Ms. Lane. Ms. Hall seconded. The motion carried unanimously.

2. Proposed Meeting Schedule for 2006

Chairman Harvey said that all the meetings for 2006 should fall on the second Tuesday of each month. Ms. Opisso said that September 11th is a Monday. Chairman Harvey stated that it should read September 12th. Chairman Harvey asked for a motion to approve the calendar as amended. Motion made by Ms. Hall and seconded by Ms. Lane. The motion carried unanimously.

VI. Public Participation

Captain Osowski noted that they placed the patrol car in the 17-92 median to slow traffic down while the new streetlights were being installed.

Mr. Leighton asked Captain Osowski for information on the drunk driving cases being overturned by the courts in Seminole County. Captain Osowski briefly explained the judges' reasoning for rejecting the scientific evidence, but noted that Seminole County is the only place in the country that is currently rejecting it.

VII. Adjournment

Ms. Hall moved to adjourn the meeting. Ms. Lane seconded, and the motion passed unanimously. The meeting adjourned at 9:27 a.m.
