MINUTES

1. Call to Order

Chairman Warren Graham called the meeting to order at 5:30 p.m.

2. Roll Call & Introduction of New Members

Present: Warren Graham, Susan Preil, Mac McShea, Francine Eubanks, Carole Ollivier, and Barbara Rutz

Also Present: Assistant City Manager Anthony Gonzalez

Mr. Graham suggested that they vote on chair and vice-chair since it was the first meeting of 2007. Mr. McShea nominated Mr. Graham for Chairman. Mr. Graham nominated Ms. Preil for Vice-Chair. The Committee approved both nominations unanimously.

3. Approval of Minutes

• Meeting of September 12, 2006

Chairman Warren Graham asked if there were any changes or corrections to the minutes of September 12, 2006. Ms. Preil made a motion to approve, and Mr. McShea seconded. The motion passed unanimously.

4. Next Budget Cycle Funding

Chairman Graham explained to the new members the reason the Committee has not met since last September and the budget constraints during the current fiscal year.

5. City Entrance Signs/ Bus Stop Covers

The Committee discussed the entrance signs. Chairman Graham suggested they think about including “The River City” in light of the new name of the park being “River City Nature Park”. Mr. Gonzalez said he would gather all the relative information for the signs and bring it back for the Committee to revisit at the next meeting.

Chairman Graham asked if anyone knew the exact number of bus stops on 17-92. Mr. McShea suggested that they check with DOT on the rules regarding bus stop covers. There was consensus from the Committee for Mr. Gonzalez to gather information relative to the bus stop covers for further Committee discussions. Ms. Ollivier recommended using wrought iron.

Mr. McShea suggested the Committee work on beautifying the corner of Highbanks and Enterprise Roads.

6. Next Meeting Date/ Schedule

Mr. McShea made a motion for the Committee to meet monthly on the 2nd Tuesday at 5:30 p.m. Vice-Chair Preil seconded. The motion passed unanimously.

7. Public Participation

Vice-Chair Preil stated that she had noticed a number of businesses along 17-92 not keeping up with their landscaping or signage. Mr. Gonzalez said that the new Neighborhood Improvement Officer has been slowly educating the residents on the City's codes; that he is working through the City in quadrants; and that he would be addressing those types of violations in the future.

Mayor Coleman updated the Committee on a few sites in the City and the budgeting problems all of the cities and counties in Florida will be facing in light of the property tax issue.

8. Adjournment

Mr. McShea made a motion to adjourn, and Ms. Rutz seconded. The meeting adjourned at 6:10 p.m.
